OUR MISSION: To enrich the quality of life for children and adults with disabilities through outdoor recreation.

Thank you for your support for the Outdoors for All Foundation.

In the world of adaptive recreation, we're accustomed to adapting to the needs of people with many different disabilities. In 2022, as restrictions brought about by the COVID-19 pandemic lessened, we worked to restore as many of our operations as possible.

We were able to adapt and restore so many of our life-enriching programs thanks to the support of hundreds of volunteers, a dedicated staff, and countless donors. By staying true to our mission, vision, and values we were able to safely restore many more of our life-enriching adaptive recreation programs that were so significantly disrupted by the onset of the pandemic.

When the pandemic first struck in 2020, it was like a series of circuit breakers going off, shutting down so many of our activities. This past year, it was like turning back on a series of dimmer switches. We were successful at bringing back many of our programs to full capacity, others we were still working to do so as the year went on.

PROGRAMS – With updated safety protocols in place we successfully:



Expanded the Adaptive Cycling Center for a full six months for seven days a week of free bike rentals



Delivered partner program custom events with schools, hospitals, and other nonprofits

Restarted summer day camps for kids with disabilities in Seattle and on the Eastside of King County

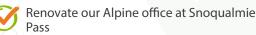
Offered on-snow programs at both The Summit at Snoqualmie and Stevens Pass

We did everything in our power to restore access to life-enriching experiences in adaptive recreation, and the teamwork and hard work paid off. The feedback we received was very positive. Participants, family members, and volunteers all noted how much they appreciated our efforts to decrease social isolation, increase physical fitness, and foster mental health. FUTURE PLANS – Several years ago, we began our Launching Possibilities capital campaign. This campaign already has helped us:



Expand effective programs like the Adaptive Cycling Center



Acquire more vehicles and trailers for transportation



Invest in state-of-the art adaptive sports equipment

Provide much more financial aid, so that as we scale our programs, economics will not be a barrier



Our Launching Possibilities Initiative is now focused on opening a network of basecamps in the Puget Sound Region. In 2023, we expect to open an Eastside of King County base camp, expand our Snoqualmie Pass winter office into a year round base camp, and set the stage for two other new bases of operation in 2024. Stay tuned!

Outdoors for All is accustomed to relying on collaboration and partnerships. Our decades long partnership with The Summit at Snoqualmie continues and is stronger than ever. We also collaborate with many other groups such as the City of Seattle, Washington State Parks and Recreation, Cascade Bicycle Club, other nonprofits, hospitals and schools. Collaboration may be a buzzword for some other nonprofits, but for us, it is a strategy that's built into our organizational DNA.

Thankfully, we are all the more appreciative of our supporters who have helped us to weather the storm. Our board of directors and staff team members are both pragmatic about the challenges that remain with us today yet also optimistic about the opportunities of the future that we are working to achieve.

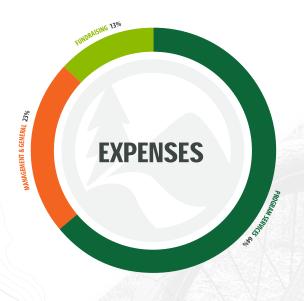
